

JR. QUEEN RULES

1. All contestants must be female, residents of Calhoun County, enrolled in 6th-8th grade.
2. Contestants must turn in application, signed rules, sponsor forms, (copy as needed) sponsor money, and regular photograph for Miss Photogenic contest (No glamour shots) by the due date.
3. Contestants must give each of their teachers a teacher form, and they must be turned in, by the teacher, by the due date. Please copy as needed.
4. Contestants will ride on the contestant's float in the Calhoun County Fair parade on Saturday, October 8, 2011. Correct attire for the float is western wear. Please be at the line up location by 9:30 a.m.
5. Contestants must attend rehearsal on Monday, October 10, 2011, at 7:30 p.m. at the Fairground Pavilion.
6. Contestants will attend contest on Tuesday, October 11, 2011, at 7:30 p.m. at the Fairground Pavilion.
 - Contestants will wear western attire (jeans, western style shirt, and boots.) Accessories are optional (hat, bandana, vest, belt, etc) No Props allowed. Western skirts/dresses, longer than knee length, are acceptable.
 - Contestants will answer questions on the night of the contest, based on their application.
7. Contestants must not be married and never have been married.
8. Contestants must not have a child or be pregnant.
9. Jr. Queen must remain enrolled in school, not be married, pregnant, or have a child during their reign, or they will be required to relinquish their title.
10. Jr. Queen must be available during the entire fair and her entire reign, attending 100% of all parades and scheduled events. If the winner cannot fulfill her obligations, then all prizes must be relinquished, and the title will be awarded to the 1st Runner Up.
11. Any other behavior deemed inappropriate by the Fair Queen committee will result in relinquishment of title and prizes.
